ESINet Update (Tom Rogers)

Due to project delays, network build, and vendor issues dates for project completion is now expected to extend beyond 2022. As of August 8, 2022, we have 124 PSAPs migrated to ESInet.


The remaining three (3) PSAPs: Anson – has no expected date, Northampton – cutover scheduled November 2, and Wilkes – cutover scheduled August 30. A 100% migration attainment should be achieved with the final three. Anson County is at risk for delay due to the selective router not being able to accept SS7 connection from ESInet. Wilkes recently received dates from Motorola / cutover scheduled for August 30, and Northampton recently received dates upon completion of fiber construction for November 2, 2022.

- Cybersecurity Remediation
 - Ad hoc committee continues to plan remediation opportunities and looking to announce a remediation project in October – more information/details to come.

- 3 jurisdictions remain to reach 100% i3 readiness (as of 7/25/2022).
 - Cleveland County and Kings Mountain not scheduled (833 critical errors/98.9%) NCCGIA remains engaged with Cleveland County.
 - Onslow County Q3 migration (64 critical errors/94.46%)
- NCCGIA and GeoComm are continually working with jurisdictions. All jurisdictions remain engaged.
- RFAI PSAPs: 24 i3 PSAPs: 100
- Statistics
 - o Total Population served by NG 911: 10,477,959 (99%).
 - o Total land mass covered by NG911: 7,328.7 sq. mi. (96%).
