Offender Access Report

Offender access reports are available in two formats, summary and detail. A summarized report displays who accessed a specific offender within your agency for a given period of time. This report counts the number of times an offender record was accessed and/or printed. A detailed report displays who accessed a specific offender within your agency for a given period of time. This report details the dates and times an offender record was accessed and/or printed.

Instructions:

An AGENCY Chief Executive Officer or the CJLEADS Authorized Administrator must complete and email the request form to the CJLEADS Production Services team via email at cjleadsaudit@nc.gov. If an agency does not have scanning capabilities, the signed form will be accepted via fax (919-754-6957) or mail (4101 Mail Service Center Raleigh, NC 27699-4101). However, CJLEADS Production Services will confirm the report request with the agency executive through a follow-up email and/or phone call.
