








# A Word from Your RCs...



#### GIS DATAHUB UPLOADS

The best practice is for your jurisdiction to upload GIS data every 30 days. Remember - if your GIS data has critical errors, call routing will be based on the last critical error-free upload and that could impact 911 call processing times negatively. You can see the status of the last GIS upload on the 911 Board's website. If you are delinquent or have critical errors, you should be receiving weekly email notifications from GeoComm and your Regional Coordinator. If you have staffing changes for those who are uploading the data who will need access to do so in the hub, please contact your Regional Coordinator so they can request GeoComm grant access to the appropriate individual(s).

#### RADIO CHECKS ON SW CALL

Radio checks are performed every third Tuesday of every month. All 911 Board funded PSAPs are called on Statewide call, starting at 9:00 AM. It is important that your PSAP is responding to the radio checks. The purpose of these radio checks is to ensure PSAPs across the State are able to communicate in the event of an emergency. If you have questions about this, please contact your Regional Coordinator.

#### **ELIGIBILITY REQUESTS**


Please submit any eligibility requests to <u>PSAPeligibilityrequest@nc.gov</u>. When eligibility requests are sent to personal staff email addresses, it only delays the response time. Be sure to submit the appropriate documentation with your requests, such as scope of work, appropriate diagrams, and itemized detail.

The Approved Use of Funds list provides a great general overview of items and technology needs that can be purchased using emergency telephone system funds.

If you are looking for a more detailed list of items that can be purchased, please see the phone/hardware/software tabs located in the FY2024 revenue expenditure report workbook which is available on the 911 Board's website. These lists include more detailed vendor-specific expenses you may see on a quote or invoice and are updated every year by our staff. It takes a lot time for staff to review quotes in order to keep these tabs updated, so please review them when completing your revenue expenditure report or when you are making purchases!

#### HAVE YOU FOUND YOUR FOUR FRIENDS?


Hurricane Helene highlighted the importance of alternate/abandonment routing for PSAPs across the state who were impacted by the storm. If you have not found four PSAPs to build alternate/abandonment routes with, reach out to your Regional Coordinator for assistance. It is better to have a plan and not need one, than to need a plan and not have one. For those who have their four friends, do you have formal agreements (like an ILA or MOU) in place? A handshake is not a formal agreement. Remember, formal agreements become part of your PSAP's backup plan.



The NowGen 2.0 Roadshows will provide the Board's current and new contract partners with the opportunity to showcase their 911 Now Generation 2.0 products. # GOVDELIVERY: DELIVERING IMPORTANT MESSAGES AND ANNOUNCEMENTS TO YOU

If you are not signed up, or do not have a representative from your PSAP signed up to receive notifications about training announcements and NMAC notifications, you are missing out. To be added, or to have someone in your PSAP added to receive these notifications, contact the NMAC at 911nmac@nc.gov or by phone at (855)662-2911.

# STAY INFORMED ABOUT UPCOMING 911 BOARD MEETINGS WITH GRANICUS

Use the 911 Board's website to subscribe to notifications for the meetings of your choice (Board/Committees). These email notifications include updates to posted agendas, agenda packets, and 911 Board and Committee Meeting minutes. Each year, each subscriber list will be reset to remove email addresses which no longer exist, so be sure to re-subscribe to continue receiving notifications!

#### **CONTRACT ADMENDMENT WITH AT&T: NOWGEN 2.0**

The 911 Board recently amended its ESInet contract with AT&T, so PSAPs across North Carolina will begin to see additional benefits and enhancements to their ESInet services.

#### Things that will remain the same include:

- The ESInet and its NG911 capabilities (including routing to alternate/abandonment paths).
- AT&T VPN (AVPN) and FirstNet are still provided through the contract.
- GeoComm will continue to provide GIS services to PSAPs.
- All services provided through the Board's contract will continue to be available to Primary PSAPs at no cost to the PSAP.

#### Multiple Upgrades Implemented for all Primary PSAPs, including:

- Upgrades to the 911 ESInet service.
- New Options for Data Analytics and Hosted Call Solutions, with the addition of Call Monitoring Display.
- Increased Training Opportunities offered by all vendors for CHE, data analytics, and GIS.
- AT&T Personnel dedicated solely to NC NG911.

#### <u>SIP ADMIN</u>

There is still opportunity to sign up for SIP admin service if you have not done so already. Reach out to your regional coordinator to get added to the project calls.

#### **AT&T TIGER TEAM**

AT&T has implemented a "Tiger Team" of dedicated technicians, assigned per region at the discretion of AT&T and Bord staff. These are personnel dedicated solely to NC NG911.

The process for reporting issues or requesting services has not changed. PSAPs will still report any issues to the NMAC, and the NMAC will coordinate with the technicians. PSAPs are **NOT** to contact technicians directly for any issues or requested services. Please note that doing so could result in a direct bill to the PSAP for related time and service should it be deemed unnecessary for a technician to be engaged either remotely or onsite.

# REMODELING OR BUYING NEW FURNITURE FOR YOUR PSAP?

For any equipment moves (intrabuilding or interbuilding, including moving equipment for cleaning or remodeling), the PSAP must coordinate with the Regional Coordinator and NMAC 90 days in advance of the move to schedule it.

As a reminder, PSAPs do not own AT&T equipment, including call handling equipment.

If the equipment is moved by the PSAP, all costs associated with this move will be the responsibility of the PSAP for direct payment to AT&T. Any damages or configuration issues that may result from such move will also be the responsibility of the PSAP for direct payment to AT&T for any associated costs. None of these costs are ETSF eligible.



#### **VIRTUAL ACADEMY**

All Primary PSAPs in the State have attended administrative training to start the onboarding implementation process for Virtual Academy. Several PSAPs are using it for its full functionality and building training for their staff. Available education opportunities have been added to the Virtual Academy calendar.


# **GEOCOMM DATAHUB**TRAINING WEBINARS





#### REVENUE EXPENDITURE REPORTS

We are over halfway through the fiscal year, so begin gathering your report documentation now so you are not rushing to do so at the close of the fiscal year in July.

# NC 911 BOARD FY2026 GRANT PROGRAM VIRTUAL WORKSHOP

The FY2026 PSAP Grant Program will begin soon. The grant application will be made available to PSAPs on March 28, 2025, with a submission deadline of May 30, 2025 at 11:59 PM.

There will be a virtual grant workshop hosted for all potential applicants on Wednesday, March 26, 2025, 10:00 AM – 12:00 PM. Each attendee must register to attend this mandatory workshop if the PSAP wishes to apply for a grant. Registration must be completed by Monday, March 21. No late registrations will be accepted.

This is a required meeting for all PSAPs wishing to submit a grant application this cycle.

The workshop will focus on the grant priorities, the application, evaluation process, and reporting requirements. Attendance is open to PSAP managers and those deemed appropriate for the submission and administration of the grant for the locality. Consultants or third-party project management vendors are allowed to attend but may not do so in lieu of the PSAP or locality staff.

#### **FUNDING RECONSIDERATIONS**

## New Reconsideration Requests for FY2026

Funding reconsideration requests are due February 28, 2025. If you believe your PSAP will need a funding reconsideration and have not already discussed with your Regional Coordinator or Financial Review Specialist, please reach out quickly so staff can schedule time to work on the reconsideration form and financial planning tool. With the deadline rapidly approaching, our calendars will fill up fast. The next funding reconsideration opportunity will be after final distribution letters are received, with a August 31, 2025 deadline. The form is available on the 911 Board's website.

# Open Approved FY2025 Reconsiderations

If you have a funding reconsideration that you have not requested the funds for, please be sure to do so prior to the close of the fiscal year. Remember, funding reconsiderations are only good for the fiscal year and purpose for which they were approved. If you received one for a project and you will not be invoiced until next fiscal year for all or part of the project, please let us know so we can plan for the additional reconsideration ask in the upcoming fiscal year.

#### **GRANTS**

#### **Portable Radio Grants**


When submitting for final reimbursement for your portable radio grant, please follow the directions in your Grant Agreement, including the template in Exhibit B. All documentation must be submitted in one PDF packet and named appropriately via email to 911grantprogram@nc.gov.

#### **Open Grants**

Grant reports are due on the 5th of every month. These reports should be named with the correct naming convention and submitted to the 911GrantProgram@nc.gov email address. For examples of reports, review the consent agenda in the 911 Board meeting agenda packets, where all monthly reports are included in the consent agenda portion.

Please be mindful of the expiration dates on your grant agreements. If you feel you will need an extension, you must follow the instructions in your grant agreement to request an extension no less than 90 days from the date the grant agreement expires. Also, if you are requesting an extension, be sure you request an extension that will give you enough time to get your project compete, as only one grant extension will be given.
