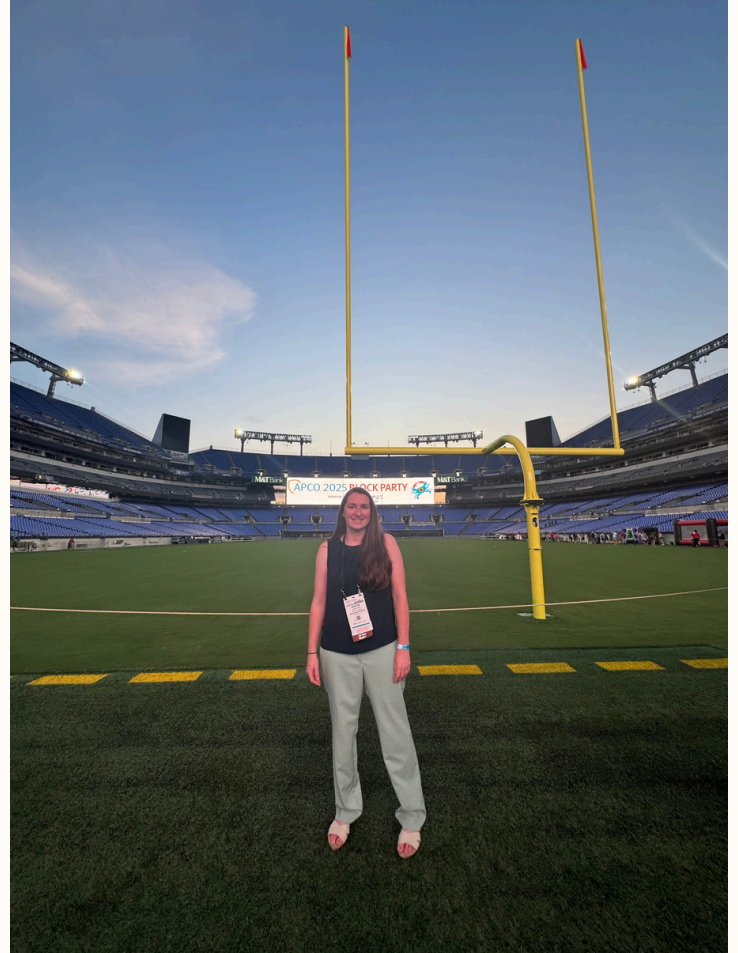

North Central Regional Coordinator Brian Short was on site during Granville County Emergency Communications' transition to a hosted call handling platform.

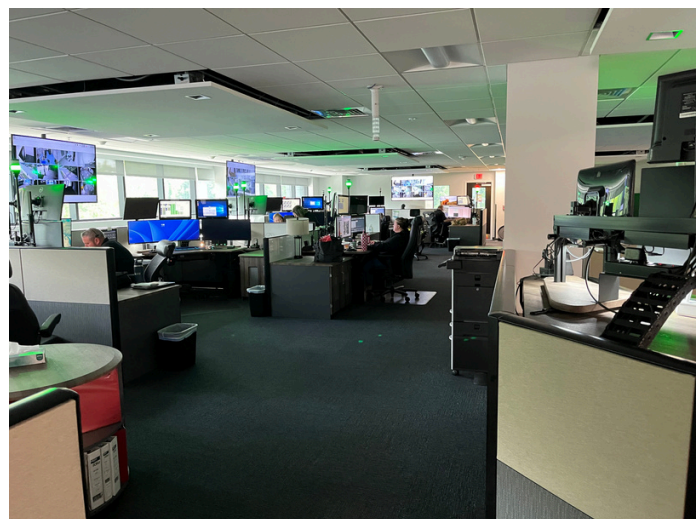

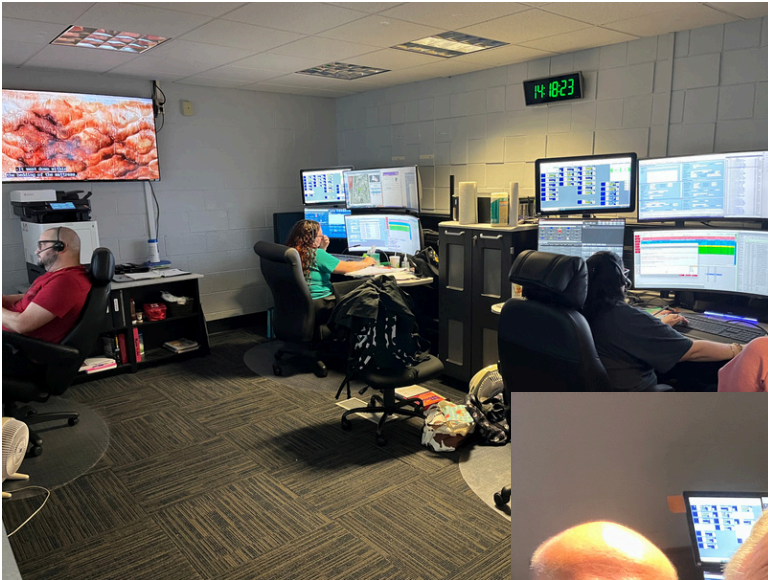

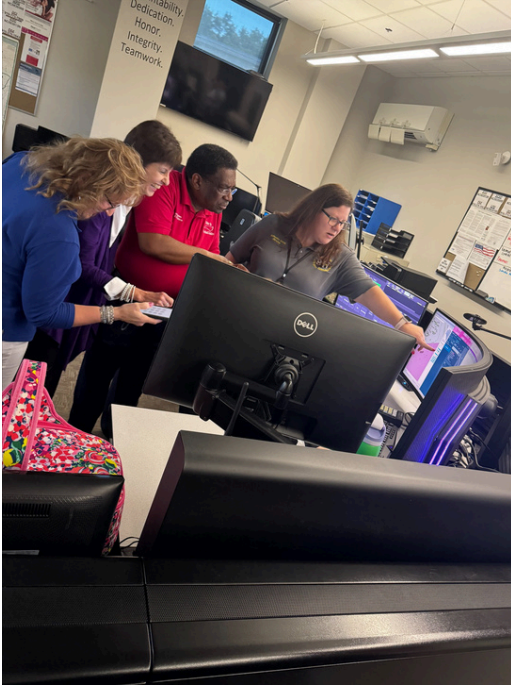

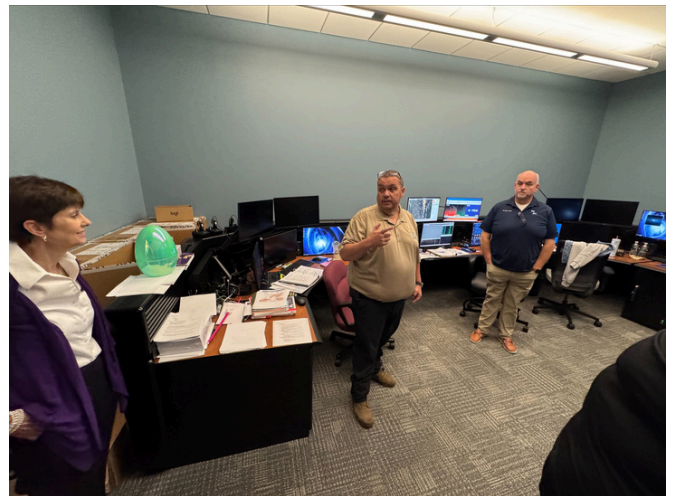

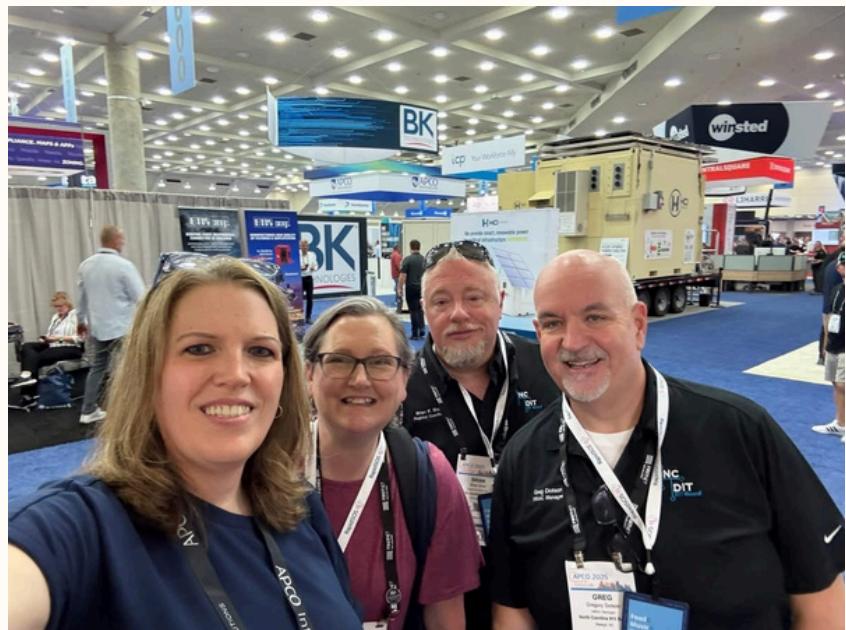

Hurricane Season is Here...Does Your PSAP have Four "Friends"?

Hurricane season is upon us. If you have not already worked to establish your four partner PSAPs for alternate and abandonment call routing, please contact your Regional Coordinator. You should be establishing agreements with your partner agencies, to include language on how 911 call information will be sent back to the primary PSAP and how calls will be dispatched in the event of an evacuation situation. Don't get caught without a plan!

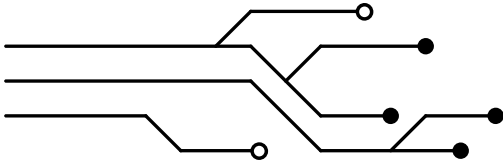

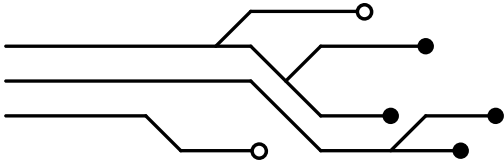
Meet the NMAC Team

- **Any details you have available**
- **What did you hear?**
- **Busy signal?**
- **Disconnected call tone?**
- **Dead air?**

PSAP Eligibility Procedure Training

The Finance Team conducted eligibility training sessions, two on Wednesday, August 9, and two on July 16 to share with the PSAP managers how to conduct preliminary eligibility reviews on quotes from vendors. The PSAP preliminarily reviewing quotes will help to streamline the eligibility request process with Board staff.

FY2025 Revenue Expenditure Report Deadline

The FY2025 revenue expenditure report submission deadline will be here before you know it. Please be sure to submit your FY2025 revenue expenditure report by **September 2, 2025**. You should be working on updating the FY2027 Financial Planning Tool to submit as well.

FY2026 Funding Reconsideration Deadline

Not going to have enough ETSF monies to complete projects for the upcoming fiscal year? You may need a funding reconsideration! The deadline for the second opportunity for a FY2026 Funding Reconsideration Request is **August 31, 2025**. Revenue Expenditure reports for FY2025 need to be submitted for review and ideally finalized prior to submitting the Funding Reconsideration request form so staff can meet the deadline to present the reconsiderations at the September Funding Committee and 911 Board meetings for approval. Reach out to your FRS or RC if you have additional questions about the reconsideration process. The Funding Reconsideration form is available on the NC 911 Board's website under "Forms & Documents."

What do I need to submit with my FY2025 Revenue Expenditure Report?

The FY2025 revenue expenditure report submission will require several pieces of documentation, including the following:

- Excel version of the FY2025 Revenue Expenditure Report, filled out in its entirety. This should include comments about the purchases made using ETSF.
- Cover page signed by the Finance Director or their designee. Expenditures on the cover page should match expenditures on the revenue expenditure report.
- FY2026 Budget.
- FY2025 invoices paid using ETSF in PDF format. Invoices should be in the order they appear on the revenue expenditure report. If need be, the invoices can be submitted in multiple packets based on the sections of the report. For example, phone and furniture invoices, hardware invoices, software invoices, training invoices, and implemental functions invoices.
- Proof of payment for any implemental functions paid using ETSF, such as general ledger showing expenditure amount for functions.
- Prior eligibility determinations for invoices if submitted to staff for review.
- Applicable scopes of work, diagrams, or proposals from vendors.
