- 1. Chair's Welcome & Goals for Today's Meeting Jeff Shipp called the meeting to order at 10:00 AM and welcomed the attendees.
- 2. Roll Call David Newberry called the roll. All attendees were by phone or Teams only.



- 3. Executive Director Opening Remarks Ms. Harris shared opening comments, thanking the members for their continued dedication to the Committee. She provided a brief update about COVID-19 response advising that Regional Coordinators continue regular outreach with the PSAPs. COVID-19 impact to telecommunicators continues to remain less than 1%. PSAP managers remain vigilant with precautionary measures. Ms. Harris also advised of modifications to General Statute regarding virtual meetings. SL 2020-3, Section 4.31 adds provisions that include all votes by roll call, members identifying themselves when making motions or actions, chat session text being retained, and members being considered present only during the time they have simultaneous communications.
- **4. April 7, 2020 Meeting Minutes Approval Motion** by Bo Ferguson, Seconded by Randy Cress. Approved unanimously by roll call vote.

- 5. ESInet/GIS Implementation Update -- Gerry Means provided updates on implementation schedules, PSAP readiness status, and GIS project status. Mr. Means advised a few PSAPs have changed their planned implementation from ESInet only to hosted solution. GeoComm database will be the authority for call routing. Mr. Means advised SolarWinds is connected and moving into analytics and response metrics phase.
- 6. Cyber Security Update Mr. Means advised there has been good response from End to End Computing. Messaging materials for the assessment have been created and waiting on DIT Communications approval prior to releasing. ESInet only PSAPs will be the first group starting with sites that are currently migrated. Randy Cress advised he was very pleased with End to End Computing. He advised they have been very responsive and have had multiple team members involved. Mr. Means advised the next group to being assessment is scheduled for ESInet only migration in 2020, followed by hosted ESInet sites. Mr. Means advised the analysis tools used by End to End Computing have been vetted.
- 7. Mobile ESInet Mr. Means provided the Technology Committee Ad Hoc update. Ellis Frasier with High Point 911 and Jimmie Turbeville from Johnston County Communication Center have been added to the ad hoc for PSAP representation. Mr. Means denoted funding and security aspects needs to be investigated. Earl Struble advised it is important to explore redundancy. He also advised there were good legal questions such as FCC reporting. Mr. Struble also advised the procurement process should allow for all carriers to be able to be engaged. Pokey Harris advised John Moore brought up regulatory



matters. Ms. Harris advised during COVID19, Alexandria, VA allowed for call takers to answer from home. Ms. Harris stressed the North Carolina is not anywhere close to that capability and does not want the work of the ad hoc committee to be focused on all aspects of backup/continuity planning.

- 8. 2020 Goals Updates Mr. Means said there were delays due to COVID-19 and advised completion dates of the goals would need to be changed. He advised it has impacted the ability to migrate 60 PSAPs. The last migration was in February. Beginning with Mitchell County in May, and if the project can stay on schedule, 45 migrations could be completed this year. Jude O'Sullivan advised the current goals were unrealistic and in doubt. Committee Chairman Jeff Shipp advised 40 migrations would be phenomenal and we would have to see how it goes starting back up. Mr. Means publicly thanked AT&T for working with the 911 Board on scheduling and denoted that AT&T is under travel constraints as well. Ms. Harris advised the two day PSAP workshop was set to discuss backup planning, and unfortunately has been cancelled due to COVID-19 and ongoing scheduling implications. She advised we may want to look at a group to address backup models as we may not be able to get a large group together. She advised Regional Coordinators can look for potential members.






- Introduction to first group of PSAPs to begin assessment on 5/27 and 5/28

SIP Admin Lines Update

- Delivers admin calls via the ESINet
- Requires number porting to AT&T regardless of local LEC
- 911 Board is the "customer"-working on sub-accounts plan for PSAPs
- PSAP to PSAP is on-net and Calls follow user groups i.e. as BOE
- Access circuit costs and SBC billed to Board-Analyzing cost offsets vs gateways and POTs
- Currently utilizing an estimated 1400 POTs circuits
