1. Chair's Welcome & Goals for Today's Meeting – Jeff Shipp called the meeting to order at 10:00 AM and welcomed the attendees.



- 2. Roll Call David Newberry called the roll. All attendees were by phone or Teams only.
- 3. Executive Director Opening Remarks Ms. Harris announced the retirement of 911 Board Staff member Ronnie Cashwell. Ronnie will retire at the end of August. Ms. Harris thanked Ronnie for his service and technical expertise. Ms. Harris also advised there was an issue with call handling the week of 8/10/2020. She advised representatives from Motorola, Intrado, and AT&T have been invited to today's Technology Committee meeting to provide an overview of the incident.
- **4. June 11, 2020 Meeting Minutes Approval –** Motion by Greg Hauser, seconded by Rachel Bello. Approved unanimously by roll call vote.

- 5. Jacksonville PD ESInet Migration Gerry Means advised the Jacksonville PD migration started at 0900 on 08/12/2020. He noted that migrations typically take 4 hours to complete. During the migration, an issue was identified regarding abandoned calls not being seen and the ANI/ALI information was missing from the abandoned calls. The issue was escalated to highest levels of AT&T, Motorola, and Intrado on the evening of 8/12/2020. A troubleshooting team reconvened at 05:30 8/13/2020. It was determined that a reboot of the server was required. The server reboot resolved the problem and abandoned calls presented as designed. Ms. Harris thanked the partners from AT&T, Motorola, and Intrado and advised a root cause analysis (RCA) is expected in the next two weeks. Pat Thetford with AT&T spoke to the great partnership with the State of North Carolina and Motorola. Ed Becker with Motorola advised Motorola is committed to a long-term relationship and pledged long term support. Chief Mike Yaniero with Jacksonville PD thanked AT&T, Motorola, 911 Board Staff. Chief Yaniero noted he appreciated the escalation and looked forward to an RCA. Josh Briggs with AT&T stated Jacksonville PD passed rigorous operational readiness testing (ORT), all pre migration and post migration tests passed. Mr. Briggs stated McDowell County is also i3 and did not experience the same issues as Jacksonville did. Mr. Briggs noted there is a plan in place to continue troubleshooting. Ms. Harris stated North Carolina is doing something that no one else in the country has done and it is possible that issues will come up. She stated she is pleased with the response from partners.
- **6. ESInet/GIS Implementation Update --** Gerry Means provided NG911 project status updates. Mr. Means advised 46 PSAPs are on the ESInet. The Chowan County migration scheduled for 8/13/2020



was delayed because of potential issues related to those with the Jacksonville PD migration. Progress has been made with military partners including contacts made with Seymour Johnson AFB.

- 7. GIS Update Mr. Means advised every county is engaged in the GIS effort. Twenty-three are EGDMS production ready. Gerry thanked partners at NCCGIA and GeoComm for their efforts. Mr. Means advised meetings were held with Georgia and Tennessee to align state borders. Ms. Harris thanked the Regional Coordinators for conducting regional coordination, regional meetings, and one on one meetings with the PSAPs.
- **8. NMAC–** Mr. Means advised SolarWinds is proving its value and has allowed NMAC staff to be proactive in identifying network and circuit issues. The NMAC has also provided support with 911 legacy services disruptions and operational issues.
- 9. Cyber Security Mr. Means advised 40 PSAPs are engaged for assessments. Four assessments have been completed. Mr. Means advised when 1/3 of assessments are complete, and preliminary reports will be provided. John Moore asked if there was a long-term plan for assessments. Ms. Harris advised it needs to be added in the strategic planning and funding. Mr. Means stated he hopes for well defined standards and to make it sustainable.
- **10. SIP Admin Line –** Mr. Means advised five PSAPs have committed to testing. He is working to complete package to deliver to Technology Committee.
- 11. Frontier Update Ms. Harris advised conversations were held with Frontier Communications regarding lack of planning for operational matters. Ms. Harris advised six weeks ago 911 Board staff, with little lead time, was notified of a Frontier maintenance outage that would impact 911 call delivery to Mitchell and Yancey Counties. A meeting was called and attended by 911 Board staff, Mitchell and Yancey counties, and Frontier management. Request was made to put off maintenance due to failed testing in previous nights. During the week of 8/10/2020 Frontier conducted maintenance that impacted PSAPs in the Western region. Greg Hauser advised Secretary Hooks has been briefed as well as CISA, NC 24 Watch Center, FCC, and DHS Critical Infrastructure was notified. Mr. Bradford advised the local jurisdiction could notify the Utilities Commission. Ms. Harris advised it was prudent to track and update the State CIO and Secretary Hooks. Josh Briggs noted that lack of diversity will still cause problems with PSAPs. Ms. Harris advised she spoke with senior leadership of the local jurisdictions and advised a path forward may include making their concerns known to the Utilities Commission.
- **12.** Ad hoc Mr. Means advised the Technology Committee ad hoc group that will be discussing continuity planning has not moved forward due to the altered migration schedule resulting from the COVID-19 suspension. He advised a rough framework has been completed.







Sixteen PSAPs need to schedule plus the five PSAPs that have not initiated a project to get to 100%. Likely that 99% project completion by 9/30/2021 is doable assuming no catastrophic events and/or additional PSAP delays.

NC NG911 Deployment Map .

- NC based military bases now working through pricing and funding requirements for migration to the ESInet. Still awaiting kickoff call with Seymour Johnson AFB.
- Picking up PSAPs migrated in 2019 for i3 conversion. Sampson County was the latest to convert to i3. Now working to combine RFAI to i3 conversion and i3 migrations for multiple PSAPs in the same county. First one up is Cumberland/Fayetteville in early 2021.
- Software flaw in Hosted Vesta that resulted in Chowan/Perquimans outage has been addressed by Motorola.



GIS Update

NC Next Generation 911 GIS Services webpage

- No jurisdictions with GIS data past due. Northeast NC quadrant PSAPs are again the i3 superstars this month with eight adjacent counties all with production i3 ready GIS data or live as i3. Second place goes to the South-central sector with seven counties with production i3 ready GIS data or live as i3.
- Twenty (20) PSAP jurisdictions are live as i3. Steady progress. Twenty-eight (28) more are i3 ready

NMAC

Fully operational

- Process has begun to add one additional staff technician by EoY 2020 to support the 73ESInet sites that will be operational by EoY 2020.
- Participation level with legacy 911 outages and command of the NG911 infrastructure and AT&T support systems is exceeding expectations.



- NMAC has come into play on a number of legacy PSAP outages and has played a key role in providing initial diagnostics and service coordination. Receiving good feedback.
- Adding NMAC as resource point for GIS support by centralizing post ESInet i3 requests for ALI
 data with the NMAC. Allows ticketing of requests to build analytics on the level of activity and
 to provide operational consistency.


