ESINet Update (Tom Rogers)


Due to vendor issues, the date for project completion may extend up to the end of June 2023. As of November 9, 2022, 126 PSAPs have migrated to ESInet.

The remaining (1) PSAP: Anson – no cutover date scheduled. A 100% migration attainment will be achieved with Anson County. Anson County remains at risk due to the selective router not being able to accept SS7 connection from ESInet.

Final Migration: Anson County - Not currently scheduled

ESINet Only Statistics

50% (11) of ESINet Only PSAPs actively engaged in a Hosted Migration 82% (9) of those migrating to Vesta 18% (2) of those migrating to Viper

When Hosted Migrations and Anson are onboarded (projection):

- 64 Vesta
- 52 Viper
- 11 ESINet Only
- 91% of NC PSAPs will be Hosted
