- 1. Chair's Welcome & Goals for Today's Meeting Meeting was called to order at 10:00 AM by Chairman Jeff Shipp
- 2. Roll Call David Newberry called the roll. All attendees were by phone or Teams only.
- 3. Ethics Awareness/Conflict of Interest Statement Chairman Shipp read the Ethics Awareness/Conflict of Interest Statement. No Board or Committee members recused.
- 4. Executive Director Opening Remarks Pokey Harris delivered opening remarks. She thanked the Technology Committee members for their work and advised they have been instrumental in the ESInet migration projects. She noted that 124 PSAPs have been migrated. She stated looking forward there are several projects to address including cybersecurity remediation, SIP admin lines, and the CAD-to-CAD project.
- 5. February 2022 Meeting Minutes Approval Motion to approve minutes made by Randy Cress. Seconded by Glen Knox. Roll call vote was conducted by David Newberry and the motion carried unanimously.

- 6. ESInet Update Tom Rogers provided the ESInet update. He noted that Currituck, Charlotte PD, Fire, and Medic were migrated. He advised he attended the Currituck migration with Greg Dotson and attended the Charlotte PD migration with David Newberry. Tom recognized the entire Charlotte project team for the successful migration and noted it was a complex project with many stakeholders involved. Tom advised there are three remaining migrations (Anson, Northampton, and Wilkes Co). Mr. Shipp asked if there were any ESInetonly to hosted pivots. Josh Briggs advised there are several active projects and more to be added. Mr. Rogers advised Seymour-Johnson AFB is speaking directly with AT&T, preparing to execute a mutil year contract for ESInet connectivity. Mr. Rogers noted that staff and an ad-boc is looking at cybersecurity remediation. He noted that specific vulnerabilities could not be discussed on an open call.
- 7. GIS Update Mr. Rogers provided the GIS update. He stated that PSAPs have been given a deadline of June 30 to be is ready with data at 98%+ and no critical errors. Mr. Shipp asked how often PSAPs should upload their data. Mr. Rogers stated monthly is preferable.
- 8. Data Analytics Update Mr. Rogers provided the data analytics update. He noted that the project timeline is being finalized and user training would begin soon.
- 9. SIP Admin Line Update Mr. Rogers noted the SIP Admin project has been rebooted. Perquimans and Union will be finished, then Carteret, Durham, and Richmond will be added to the pilot. Ms. Harris said staff was reviewing with NC DIT and looking at a price structure. SIP admin lines are not a 1-to-1 match with legacy offering. Pricing model could be concurrent call paths. She noted the purpose of the pilot is to work through details and address concerns.
- 10.NMAC Update Greg Dotson provided the NMAC update. He stated a new Tier 2 would be starting July 5. He stated a meeting is scheduled with DIT facility management to discuss requirements of moving the NMAC and other staff position work spaces to the old printer room at the DIT data center.
- 11.AT&T Update Josh Briggs provided the AT&T update. He noted an Intrado Tier 3 technisian is still on site in Raleigh. He advised a project is in progress to move the Viper system to a single 6 node architecture. He advised the team is waiting on hardware at the host. He stated the team is still waiting on hardware ordered in September 2021 to turn up Vesta 3. This impacts projects pivoting from ESInet-only to hosted ESInet. Mr. Briggs advised multiple OSP migration projects have either been kicked off or have been ordered including Verizon Wireless, ATTMO, Wilkes Telephone, ATMC, Intelliquent, Frontier, RTMC, Century Link, Surry Telephone, and Carolina West. He stated negotiations are continuing with Windstream. He noted this portion of the ESInet project is ahead

of schedule. Ms. Reeder reported that there is a communications service provider that has questioned whether the Board designated the points of interconnection (POIs) for the ESInet, as required by G.S. 143B-1406(e1)(2). The response that the Board has offered to that communications service provider, through the Chair, is that the Board designated the POIs when it entered into a contract in June 2017 with AT&T and charged that company with creating and implementing the ESInet. However, to further address this concern, there will be an item on the Board's June agenda to ratify the POIs established by AT&T.

- 12. Closing Remarks Ms. Harris provided closing remarks and again thanked the committee and noted the importance of maximizing the ESInet and continuity planning. Mr. Shipp asked for some highlights of "NG911 2.0" and what would come in the future. Ms. Harris noted that CAD-to-CAD, continuity, and data sharing opportunities would come next and would be broad. Ms. Harris also noted the National 911 office commissioned a nationwide study about standards for data sharing. Mr. Briggs noted that NC Emergency Management is planning to connect to the ESInet.
- 13. Adjourned Mr. Shipp adjourned the meeting at 10:58

## **ESINet Update (Tom Rogers)**

Due to project delays, network build, and vendor issues dates for project completion are now expected to extend until third quarter 2022. As of June 27, 2022 we have 124 PSAPs migrated to ESInet.


The remaining three (3) PSAPs: Anson, Northampton, and Wilkes are expected by Q3, 2022. A 100% migration attainment should be achieved with the final three. Anson County is at risk for delay due to the selective router not being able to accept SS7 connection from ESInet. Wilkes recently received dates from Motorola / cutover scheduled for August 30, and Northhampton has been delayed by fiber construction.

- Military Sites Update
  - Seymour Johnson AFB is securing a multi-year contract with AT&T to onboard ESInet – First in Country to Nationwide AT&T ESInet
  - NCEM 24hr Watch to onboard ESInet Contract stage now
- Cybersecurity Remediation
  - Ad hoc committee discussing remediation opportunities and planning to launch a remediation project in October – more information/details to come.

# SIP Admin Lines Update (Tom Rogers/Pokey Harris)

- Pilot project has been revived.
- Perquimans County and Union County scheduled to complete setups in July



### Cloud Based CAD-to-CAD (Tom Rogers/Pokey Harris)

Motion to approve the staff recommendation of 50% for the CAD-to-CAD cloud-based subscription service such as the Unify hub provided PSAPs can provide formal agreement to receive and dispatch 911 calls (ILAs, SOGs, SOPs) between primary PSAPs and to include secondary PSAPs. The motion also provides that for those PSAPs with formal agreements in place for approval of 100% of the eligible costs of the CAD-to-CAD cloud-based subscription service if the vendor can provide an invoice showing eligible and ineligible costs clearly notated.
