**ESINet Update (Tom Rogers)** 


Due to project delays, network build, and vendor issues dates for project completion is now expected to extend beyond 2022. As of November 9, 2022, we have 126 PSAPs migrated to ESInet.

The remaining (1) PSAP: Anson – no cutover date scheduled - OSP has reengaged, Northampton – cutover on November 9. A 100% migration attainment will be achieved with Anson County. Anson County remains at risk due to the selective router not being able to accept SS7 connection from ESInet.

#### NC Next Generation 911 GIS Services Webpage

- 0 jurisdictions remain to reach 100% i3 readiness (as of 8/26/2022).
- NCCGIA and GeoComm are continually working with jurisdictions.
   Focusing on data upload frequency and accuracy
- RFAI PSAPs: 22 i3 PSAPs: 104 (with Northampton)
- Statistics
  - o Total Population served by NG 911: 10,566,375 (99%).
  - Total land mass covered by NG911: 48,619.57 sq. mi. (99%).
