If the IT Project is ready for SCIO review/approval, the EPMO Manager will prepare the <u>0300-0365-005-D PROJECT DECISION MEMO FORM</u> for routing.
- **6.2** The EPMO Manager will submit the completed <u>0300-0365-005-D PROJECT DECISION MEMO FORM</u> to the SCIO (or designee) via email, or the Project Portfolio Management (PPM) System workflow.

If the SCIO (or designee) disapproves, the IT Project is returned to the Agency for revision or cancellation. The EPMO will provide revision requirements in accordance with <u>0600-0600-005-B</u> <u>CORRECTIVE ACTION PROCESS</u>.
- **6.4** The EPMO will archive the completed <u>0300-0365-005-D PROJECT DECISION MEMO FORM</u> in the EPMO Project Management document repository.
