IT Expansion Pilot



Background

- IT requests are often large/complicated and have high impact on:
 - Agency operations
 - The state's constituents
- Partnered with OSBM to pilot a review process that helps:
 - Inform decisions about IT investment
 - Find opportunities for economies of scale and/or to reduce duplication
 - Ensure that the IT programs/projects included in the state's budget are sound

IT Expansion Pilot



Process/ Results

- In late 2021 we began working with OSBM to enhance the expansion review process
 - Created a survey with IT-specific questions addressing the 4 focus areas
 - Presented the new survey questions to CIOs
 - Formed a team of SMEs from OSBM and DIT to review requests
- To date we have reviewed 30+ requests from 10 agencies
- Additional agencies' requests are forthcoming

Roadmap Progress Updates

- Six Month Progress Report (Early Focus items)
 1. Promote enabling infrastructure and system integration.
 2. Stimulate inter-agency coordination and collaboration toward common solutions.
 3. Improve awareness of and easy access to secure state systems for all constituents.

The Committee has been impressed with DIT Staff performance. Items remain red due to lack of resources, yet-to-be-established interagency cooperation, and shared committee/working group to pursue Digital Transformation.

Progress Updates:

Promote enabling infrastructure and system integration

- Source solution for a Common Digital Identity
 - + Technical
 - Policy (merging personas), Shared Vision, Early Adopters, Fallback/Mitigation
- Identify systems of record for data types; pilot Business One-Stop within Constituent Portal (CP)
 - ± Technical (CP on track); Biz1Stop just starting
 - Policy (ID systems of record), Shared Vision, Early Adopters, Dedicated Resources
- Map ecosystem of solutions toward common approaches; starting with PayIt system
 - Mitigations from DT Roadmap not in place: vet and establish new governance body within 90 days, together with Agency CIOs

Progress Updates:
Stimulate inter-agency coordination and collaboration toward common solutions.

- ➤ Evaluate digital driver's license as a "quick win" and pursue common standards (e.g., PayIt)
 - ± Policy (PayIT standard established); digital DL being discussed w/ DMV
 - Mitigations from DT Roadmap not in place: e.g., DOT-DHHS-DIT collaboration
- ➤ Maturity assessment w/ DPI, DHHS, Commerce
 - Resource gap (dedicated Project Managers, Business Analysts, Systems Analysts required to move these forward)
- ➤ Defer most initial programs with local government until progress is made
 - As above, Resource gap hinders progress

Progress Updates:
Improve awareness of and easy access to secure state systems for all constituents.

- ➤ Establish DT “roadmap” of features + timelines
 - Communications campaign still pending, but early coordination w/ Constituent Portal has occurred
- ➤ Inventory state system data on citizens
 - ± New CPO onboard; leveraging for DT Roadmap projects not yet underway
 - As above, resource gap hinders progress
- ➤ Continue efforts to secure DIT systems; partner with DHHS on protecting private data
 - + Very good progress as reported by ITSB Cybersecurity Committee; DHHS security and architecture routinely reviewed

Potential Needs

- Legislative Needs for Long Session:
 - Digital Transformation Office w/dedicated resources
 - Est. #/size based on our experiences???
 - Chief DT Officer
- Communication Needs to promote Digital Transformation
 - Approaches need to leverage all available resources
 - ITSB+DT -> Agency & Local Electeds, CIOs
- Governance Needs to achieve Digital Transformation
 - Collaborations have been slow to develop
 - Without strong partners and inter-Agency adoption, the impact of Digital Transformation will be limited
 - Want to leverage opportunity with Chief Data Officers to build data governance; build alignment around risk exposure

Executive Summary

The Cybersecurity Education Pathways Program, in partnership with the North Carolina Community College System, University of North Carolina System, and Department of Information Technology, will increase credentialed cybersecurity professionals to meet industry requirements. The Program will leverage the strengths of cybersecurity educational programs and public and private partnerships to remove barriers to meet the needs of North Carolina employers.



Cyber Education Pathways

Mission Statement

To recruit, educate, and graduate certified cybersecurity professionals and retain their services in North Carolina by way of continuing education, internships, apprenticeships, and full-time employment with the State's public and private sector employers.

Strategy

Leverage North Carolina Community College System and University of North Carolina System education programs to create credentialed employees to meet industry demand.
